

SUMMARY ANNUAL REPORT

For Thomas Jefferson University Retirement Plan for Faculty & Senior Administrative Staff

This is a summary of the annual report for the Thomas Jefferson University Retirement Plan for Faculty & Senior Administrative Staff, EIN 23-1352651, Plan Number 003, for the plan year January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$35,171,646. These expenses included \$43,772 in administrative expenses and \$35,127,874 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of the end of the plan year, compared to \$492,799,593 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$492,799,593. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$26,314,729, including employer contributions of \$15,717,184, earnings from investments of \$7,332,474 and other income of \$3,265,071.
